



## **Klahoose Wilderness Resort**

### **Booking Terms and Conditions**

Klahoose Resort Limited Partnership (referred to in this document as Klahoose Wilderness Resort, "Resort" "us", "we", or "our", a company located at #203-4400 Marine Avenue, Powell River, British Columbia, Canada, V8A 2K1.

#### **Rates, taxes**

All rates are in Canadian Dollars, per person based on double occupancy, unless otherwise stated.

All rates and fees are subject to tax at 5% GST and 10% Hotel Tax (8% PST and 2% MRDT).

Note: The Municipal and Regional District Tax for our region is scheduled to increase from 2 percent to 3 percent effective May 1, 2026. The updated 3 percent tax will apply to any 2026 booking where final payment is made on or after May 1, 2026, including reservations confirmed in advance with payment due on or after that date.

Should other taxes or fees be required they will be advised. All rates, taxes or fees are subject to change without prior notice.

#### **Service Fee**

The Service Fee includes staff gratuities and many activities and use of facilities at the resort including: WIFI, in- room tea, coffee service, snacks, wood-fire sauna, campfire area, kayaks, stand-up paddle boards, hiking trails, activities such as cedar weaving, complimentary shared airport transfers between Powell River Airport and Lund (when required).

#### **Conservation Fee**

The conservation fee collected are distributed in part to the Commercial Bear Viewing Association of BC and the North Island Marine Mammal Stewardship Association (NIMMSA). The fees go towards conservation and education of grizzly bears, marine mammals, and their habitats.

#### **Indigenous Tourism Destination Fund (ITDF)**

Your chance to support Indigenous Tourism in Canada and help fulfill the Truth and Reconciliation Commission Call to Action #92: by ensuring Indigenous communities gain long-term sustainable benefits from economic activities taking place on their lands or using their resources. The ITDF is a fund that assists Indigenous tourism business nationwide through Indigenous Tourism Association of Canada (ITAC). Note the ITDF is optional and has a choice to opt-out.

#### **Included in Stay**

Amounts included in your bookings: meals, tours listed as included: all amenities (kayaks, paddle boards, sauna, nature trails, Wi-Fi etc.), naturalist guides, luggage handling, and land transfer between Powell River Airport and Lund, if required. Unless otherwise stated in your reservation, the following are not included in the standard booking price: accommodation incidentals, gift shop purchases.



purchases, optional tours not listed as included, extra marine or air transfers to/from the Resort, alcoholic beverages except when included at the Resort, flights, ferries from your home to our departure point, or any other services, items and amenities not expressly stated in your reservation.

### **Booking and Cancellation Policies**

- o A 10% deposit is required to make a booking
- o Balance due 45 days prior to Start Date
- o 0-44 days prior to Start Date no refund
- o From the time of booking a \$100 per person fee will apply to cancellations and date changes. Other fees may apply for added flight add on for date changes.
- o Groups with twelve or more people, 50% payment required to confirm with balance due 45 days prior to arrival. Groups deposit and balance are both non-refundable.

### **Travel Insurance**

We must adhere to our booking terms & conditions as we have limited capacity and a short season. We highly recommend all guests purchase travel insurance.

### **Travel and Transfers**

Packages include boat transfer departing Lund, BC, for the resort at 3pm on arrival day and returns between 11am-12pm on departure day. An optional shared shuttle between Lund (60 min.) is available for guests connecting with a flight into Powell River Airport. Please note the boat transfer and shuttles only operate once daily on arrival and departure days, so please plan your connecting ferries or flights accordingly. Early or late check-in/out are subject to availability, must be planned in advance and surcharges for extra boats or shuttles may apply.

### **Child Policy**

Klahoose Wilderness Resort is an all-ages resort, and welcome guests who are under 19 years old. Please note that Grizzly Bear Viewing Tours are from 10 years and over only. Parents or guardians are responsible to always monitor and supervise any minor.

### **Guest Participant Release**

Because of the nature of the activities in which our guests commonly participate in, guests must sign a Guest Participant Release prior to your stay. Minors must have a parent or legal guardian sign the waiver on their behalf. Please return a copy of such waiver executed by each guest in your party with your deposit or full payment. A copy of the waiver will be available to you upon written request to Klahoose Wilderness Resort.
